Recently, we reported that Ohio's 133rd General Assembly enacted <u>House Bill 123</u>, the "Safety and Violence Education Students (SAVE Students) Act," regarding school security and youth suicide awareness education and training. The state legislation calls for a comprehensive approach to school safety involving the Ohio departments of Education, Public Safety, Mental Health and Addiction Services and Attorney General's Office.

## THE FUTURE IS BRIGHT FOR THE STUDENTS OF RIVERGATE HIGH SCHOOL



River Gate High School is in the midst of launching the Get Focused! Stay Focused! Program through a newly created career pathways course: Gator Career Pathways. Gator Career Pathways is taught by Mr. Larry Brown and Ms. Ruth Smith-Harris with the enthusiastic support of Mr. Jason Cooper, the River Gate High School director.

"The Gator Career Program is designed to help each student answer the three following questions: who am I, what do I want in life, and how do I get it? Students are also taught critical decision making processes that will help them answer these life defining questions."

Joining hundreds of schools and over 300,000 students across the country that have adopted this curriculum, River Gate High School continues to demonstrate commitment to improving student retention, graduation rates, and overall student success.

River Gate High School has partnered with Lisa Imel, President of EdSolutions Group, to support program implementation and expand its impact. The program leads students through a self-discovery process asking, "Who am I, what do I want, and how do I get it?" At the end of the course each student will have chosen a career and a targeted workforce entry strategy which may include employment, college enrollment, enlistment, or entrepreneurship. The program aligns to meet state and national standards in English, Financial Literacy, and the Student Success Plan. Ms. Imel has guided the course teachers to incorporate Ohio Means Jobs Employability Skills and the program is being supplemented with a Career Professionals Speaker Series in partnership with community members speaking to students virtually about their experience in education, career pathways, and tips for success in life and future goals.

Chris Bufford, a River Gate Student, agrees that this class is helping him make future goals. He said" It is such a helpful class, before this class I never really thought about what I wanted to do after high school but now I feel like this is the time to start thinking about it. The vision board that we created was a real blueprint of my future. It included household budgets, what career made what money and what careers match my personality."

The chosen curriculum, Get Focused! Stay Focused!, promotes educational equity and access for all students and has been recognized as a promising practice by the U.S. Department of Labor. Students' 10-year plans will be used by the entire staff as a means to enhance student advising sessions; in addition, a recently implemented parent engagement initiative will be strategically engaging parents and utilizing the students' 10-year plans as part of the Student Success Team Meetings, led by Ms. Melissa. Future plans include partnering with a regional post-secondary partner to expand equity and access by offering the course as CCP for any students that are interested and qualify.

The course plans to culminate with a Career Pathway Showcase and mock interviews where parents, business, community, and post-secondary partners will serve as mock interviewers and provide relevant feedback to students about their academic, career, and life plan including their soon to be created resumes and cover letters!

## Approved List of Assessments Updated for the 2021-2022 School Year

The <u>Ohio Department of Education's List of Approved Assessments</u> has been updated in the following areas:

- 1. Comparable Assessments to Ohio's K-3 Diagnostic Assessment for the Third Grade Reading Guarantee (K-3 Diagnostic);
- 2. Alternative Standardized Assessment for the Third Grade Reading Guarantee (Alt Reading);
- 3. Alternative Standardized Assessment for Grades 3-8 (Alt 3-8) for Chartered Nonpublic Schools;
- 4. Alternative High School Assessments for Graduation (Alt HS) for Chartered Nonpublic Schools;
- 5. Teacher and Principal Evaluation Component (Growth Measure);

- 6. High Quality Student Data (HQSD);
- 7. Student Survey for Teacher Evaluation (Student Survey); and
- 8. Gifted Prescreening and Identification (Gifted Assessment).

## Winding Down Activities for Federal Programs



Students may be happy to have the school year coming to an end, but for school leaders it is time to finish up grant spending and start planning for next school year. Here are some reminders of activities that should be done in May and June:

- Make sure you have held the Annual Title I Meeting as required. A virtual meeting is acceptable. Keep a copy of the agenda for your documentation.
- Make sure that the last inventory of items purchased with federal funds was completed within the last two years, if not, it's time to complete an inventory.
- Have all staff that are paid with federal funds sign a semi-annual certificate indicating that 100% of their work
  was under the appropriate Title objective. If staff positions are funded by more than one grant or by a grant and
  the general fund, make sure to keep a copy of the individual's schedule to document the division of time and
  effort on federal objectives.
- Complete either the Desk Audit or Self-Survey for the Office of Federal Programs. These can be found in the Monitoring application within your SAFE account.
- Schools in Cohort 1 should have completed the One Plan by April 30<sup>th</sup>. Schools in Cohort 2-3 can complete the One Needs Assessment and copy last year's plan in CCIP to roll over to Fiscal Year 2022.
- Send out Parent Surveys before the end of school. This gives parents an opportunity to share their opinions of the Title programs as required.
- Ask your treasurer about your Special Education Maintenance of Effort (Equal or more than last year's MOE) and the Title Maintenance of Effort (within 10% of last year's MOE).
- Finalize any purchases that are funded with federal funds.
- Start discussions with all key stakeholders about plans for next year. (Remember schools are getting even more funding next year through the American Rescue Program Act, so plan carefully.
- Finalize and advertise the school's plan for extended learning as required by ESSER II.


A live, virtual Heading to Kindergarten Transition Summit is scheduled for June 3. Plan to attend to learn more about supporting successful transitions to kindergarten.

**Covid-19 Reporting** 

The Ohio Department of Health issued a <u>K-12 reporting order</u> for all student and staff COVID-19 cases. This order is specific in the requirements and is attached for your review. The requirements began September 8, 2020. To our knowledge, there is no duty to report any cases that occurred prior to September 8.

The most important steps for all schools are:

- 1. Name a COVID-19 Coordinator to facilitate reporting of information.
- 2. Within twenty-four (24) hours of becoming aware of a student, teacher, staff member or coach who has tested positive or been diagnosed with COVID-19, notify parents/guardians of the COVID-19 case.



- 3. Within twenty-four (24) hours of becoming aware of a student, teacher, staff member or coach who has tested positive or been diagnosed with COVID-19, report the case to the local health department.
- 4. Copy your sponsor at <u>coronavirus@charterschoolspec.com</u> when reporting to the local health department.
