



## 2024-2025 INTERNET OR COMPUTER-BASED SCHOOL APPLICATION TIMELINE

<b>April 3, 2023</b>	Notice of Intent to Apply for sponsorship with St. Aloysius is available on CSS website.
<b>July 3, 2023</b>	St. Aloysius begins accepting applications for any potential schools seeking sponsorship by St. Aloysius. Training will be available on the website by this date.
<b>September 6, 2023</b>	Deadline to submit all quality school applications for the 2024-2025 school year. <b><i>Applications determined incomplete or lacking information may not be scored or considered. Applicants may be asked to resubmit during the next application period.</i></b>
<b>September 11, 2023 to October 20, 2023</b>	St. Aloysius will review and score Replicator, Transfer, Existing and New School applications.
<b>October 16, 2023 to October 27, 2023</b>	St. Aloysius will conduct onsite interviews for Transfer and Existing schools.
<b>October 30, 2023 to November 3, 2023</b>	St. Aloysius will conduct panel interviews with Replicator and New School applicants that pass the initial application phase. Notice will be provided prior to October 17 to those applicants who did not pass the initial phase.
<b>November 6, 2023 to November 10, 2023</b>	Applicants may submit supplemental information/documentation within one week of their interview. <b><i>Documentation received after one week will not be considered.</i></b>
<b>November 13, 2023</b>	St. Aloysius scores panel interviews and prepares final scoresheets.
<b>November 13, 2023 to November 17, 2023</b>	Charter School Specialists to determine recommendations for St. Aloysius.
<b>November 21, 2023</b>	St. Aloysius board meeting approving/denying Charter School Specialists recommendations.
<b>November 30, 2023</b>	Notification of approval to applicants including: (a) Preliminary Agreement; (b) New School Paperwork Requirements; (c) Contract Template; (d) Contract Attachment Submission Timeline.
<b>March 7, 2024</b>	Deadline to submit the final Preliminary Agreement and all New School Paperwork to Angie Mann at <a href="mailto:amann@charterschoolspec.com">amann@charterschoolspec.com</a> .
<p><b><u>Potential Contract Dates for New Schools:</u></b></p> <ul style="list-style-type: none"> <li>• <b>January 2024:</b> Schools will receive contract template &amp; training for contract attachment submission process.</li> <li>• <b>February 2024:</b> Initial contract attachments due.</li> <li>• <b>May 2024:</b> Final contract due.</li> </ul>	
<p><b>*Existing schools are schools whose contracts with their current sponsors expire on June 30, 2024. Transfer schools are schools whose contracts with their current sponsors extend beyond June 30, 2024 AND the current sponsor has agreed to transfer sponsorship to St. Aloysius.</b></p>
