## Addressing Attendance Related to Religious Expression and School-**Sponsored Extracurricular Events**

The Ohio Department of Education and Workforce has new guidance for addressing attendance related to religious expression days, school-sponsored extracurricular events, and cocurricular activities.

#### Religious expression days

Over the summer, Governor DeWine signed House Bill 214 into Ohio law, effective Oct. 24, 2024. The House Bill created a new section in the Ohio Revised Code regarding guidelines for how schools will accommodate student absences due to sincerely held religious beliefs and practices. This language does not replace existing requirements for students to be excused for religious purposes. It does, however, allow parents to notify schools of up to three days for their child to be excused for religious expression.

- 1. In addition to being excused, all the following are true for these three days:
- 2. Parents must communicate the dates to the school within 14 days of the beginning of the school year.
- 3. The school must work to accommodate any conflicts the missing days have with academic requirements.

None of the days may count toward the "excessive absence" thresholds that schools communicate to families under Ohio

Schools and districts must adopt and communicate a policy with families and students. The recommendation is to notify school communities about the need to create this policy and that it will go fully into effect next school year. In the meantime, districts and schools are encouraged to work with families in good faith by setting a deadline for when parents can make these requests during this school year (for example, 14 or more days after they are notified this year).

#### School-sponsored extracurricular events

Schools and districts may have a policy to consider in-state, school-sponsored extracurricular events as part of the instructional day. Sometimes students must miss instructional time to participate in a school-sponsored extracurricular event such as a sports tournament or arts competition. School or district policy may allow these types of events to count as the student being "present," and would therefore not count toward the chronic absence calculation. The policy should only apply to events sponsored by the school.

#### Co-curricular activities

Co-curricular activities (for example, field trips and events connected to credited courses like music performances) are included in the school or district's graded course of study and are school-sponsored instructional opportunities. Students participating in co-curricular activities should be marked "present" for purposes of attendance.

# Governor's Science of Reading Recognition Program Recognizing Schools Implementing Practices Aligned to the Science of Reading

Ohio Governor Mike DeWine, in coordination with the Department of Education and Workforce, is pleased to announce the Governor's Science of Reading Recognition Program to recognize schools that are demonstrating strong implementation of evidence-based instructional practices aligned to the science of reading and where students are making significant progress.

PreK-12 schools, including public, community, and chartered nonpublic schools, are eligible to apply, and each school must apply as an individual building. Review the **Application Guidelines and Instructions**, which outline the requirements for the recognition. The application period is Oct. 25-Nov. 29.

#### Compliance Highlight 1: Title IV

Title IV Funds: The intent and purpose of Title IV funds is to improve students' academic achievement by increasing the capacity of schools and local communities to provide access to well-rounded educational opportunities, improve school conditions for student learning, and improve the use of technology to improve achievement and digital literacy. These funds can be used to support a variety of activities including Positive Behavioral Interventions and Support (PBIS), music and art programs, robotics, athletic programs, and school safety. Schools may also use these funds to provide field trips for students to provide them with a well-rounded education. Keep in mind that field trips must be for educational purposes. ### Compliance Highlight 2: The End of First Quarter & The One Plan

As the first quarter of instruction ends, schools should be reviewing student data and the progress on their One Plan goals. Imbedded within the One Plan system is a method to report student progress and the level of adult implementation. Once schools enter their data, the system will graph the progress from the start of school until the end of first quarter. Schools can monitor how well their interventions are working and make any adjustments needed. Using the reports generated from the One Plan, schools can see the school's progress and note areas where more support may be needed. If the school team decides they need to add or change anything in the One Plan based on the progress monitoring, they can create a revision to their One Plan. The link to entering data can be found in the One Plan under the Reports menu and Report Results. Schools are encouraged to share their school's progress with all the stakeholders.

### **College and Career Readiness Corner**

The Ohio Department of Education and Workforce is offering a College Credit Plus Teacher Credentialing Grant to help high school teachers obtain the necessary qualifications to teach college-level courses through the College Credit Plus (CCP) program. This initiative allows students to earn college credits while still in high school, reducing future tuition costs and accelerating their academic progress. Teachers who receive CCP credentials not only enhance their professional skill set but also play a key role in delivering college coursework, supporting student success in both academic and career pursuits.

For schools, this grant helps expand CCP offerings, particularly in districts where access to college courses may be limited. With more credentialed teachers, schools can increase the availability of college courses on-site, reducing the need for students to attend off-campus classes. This aligns with efforts to boost college and career readiness. The application deadline for this grant is December 20, 2024. Students engaged in friendly competitions to complete tasks such as laying flooring and testing their steady hands in welding. Lunches

were provided by the Ohio Carpenters' Union for GCA's students and staff chaperones. All together, GCA's students spent over four hours at the event.

As many of the attending students are approaching graduation, they were encouraged to network with potential employers and inquire about apprenticeship opportunities and requirements. The Ohio Carpenters' Joint Apprenticeship and Training Center is a highly anticipated field trip for Glass City Academy, and it's an experience that students frequently discuss and look forward to as they near graduation.



## Westwood Preparatory Academy - Necco Center Fall Fest 2024

Necco Center serves male students aged 9 to 22 who are diagnosed with various disabilities, including Autism and Bipolar Disorder. The event, attended by CSS's Molly Wheatley, was a collaborative effort by staff and community partners, who came together to create a memorable experience for students and their families. The campus's newly renovated gymnasium was festively decorated for fall, and attendees enjoyed a fall-themed lunch and a photo booth.

Students had the opportunity to engage in a variety of fun activities, such as pumpkin decorating, horse-drawn hayrides, caramel apple making, and fall-themed crafts. There was also face painting, and live music performed by local bluegrass group, The Frog Pond Band. Additionally, students enjoyed visiting and petting llamas brought in by Good News Llamas.
