## River Gate High School Grand Opening of its Career Tech Education Facility

River Gate High School celebrated the grand opening of its new \$3.2 million dropout recovery and career-technical education facility, marking a major milestone in its 25-year history. The ribbon-cutting ceremony brought together the Board of Directors, the school's architects, and city officials, including Mayor Doug Franklin, to recognize the investment in the future of local youth. The state-of-the-art campus is designed to provide at-risk students with hands-on career training and academic support, equipping them with the skills and credentials necessary for success in both higher education and the workforce.

During the ceremony, Head of School, Jason Cooper delivered a heartfelt speech reflecting on River Gate's mission to serve students who have faced significant challenges. He spoke passionately about the school's role in offering second chances and opening doors to new opportunities, emphasizing that the work being done is not just about education, but about changing lives. Since its opening, River Gate High School has graduated more than 1,200 students and this new building is a sign that the mission is still going strong and looking ahead to help even more students in the years to come.

## Timely Submission of Contract Modifications: Why It Matters

As a sponsor, Charter School Specialists emphasizes the importance of timely and accurate submission of contract modifications. Whether a school is changing its name, location, grade levels, or adding facilities, these changes must be formally documented and approved to remain compliant with ODEW regulations.

### Common Contract Modifications and Required Documentation

According to ODEW guidelines, the following common changes require contract amendments:

- School Name Change: Requires a fully executed amendment, governing authority resolution, updated W-9, and Secretary of State
- Change of Location: Must include a new facility addendum, resolutions, and updated sponsor assurances.
- · Adding an Annex or Modular Unit: Requires a detailed property description, resolutions, a new sponsor assurance form, and a safety/threat assessment plan.
- · Grade Level Changes: Must include revised education and financial plans, along with governing authority approvals.
- · Enrollment Area Adjustments: Require updated educational and financial plans and formal resolutions.
- Change or Addition of Management Co.: Updated or new operator agreement, resolutions.

### Why Timeliness Is Critical

Delays in submitting contract modifications can result in:

- · Operational disruptions (e.g., inability to open new facilities or serve additional grades).
- Compliance issues with state reporting and funding mechanisms.
- Visibility concerns, as all amendments are publicly posted on the Department's website.

Charter School Specialists recommends initiating modification requests well in advance of implementation dates and maintaining open communication with us to ensure smooth processing. ### Carryovers from FY25 to FY26

ODEW announced that they plan on allocating the FY25 carryover funds in January 2026 to coincide with the expected January federal reallocation of FY26 funds. Remember that schools can obtain a substantially approved date for anticipated carryover funds by entering a history log note in CCIP in the FY26 application. By establishing a substantially approved date, schools can allocate these funds prior to receiving the actual distribution of funds.

**Project Cash Requests** 

Please remember that ODEW's expectation is that Project Cash Requests will be sent in at least quarterly. Schools that delay submitting PCRs may earn risk analysis points which can impact the likelihood of ODEW conducting a desk or onsite review of the school's federal funds.

## **Special Education Reminders**



Hello, I am Dr. Erica McMillon, the new Special Education Director. With over 20 years of experience in the education sector, I am proud to serve Ohio's charter school community as a dedicated advocate for students, families, and educators. My mission has always been to promote excellence, innovation, and diversity in education while empowering both students and educators to reach their fullest potential. Having served as a Director of Special Education, Safety & Security, and Tutoring, as well as a school principal, teacher, and instructional leader, I have seen firsthand the importance of balancing compliance with meaningful, inclusive practices that strengthen school communities. In my current role with Charter School Specialists, I am committed to ensuring our partner schools have the tools, guidance, and resources they need to thrive.

As we begin the 2025-2026 school year, it is critical that schools remain attentive to key special education compliance requirements. By September 19, 2025, all final systemic evidence documents related to indicators must be submitted, including updated policies, procedures, practices, analyses, and improvement plans. These documents must demonstrate alignment with Special Education Profile indicators such as disproportionality, evaluation timelines, discipline, and least restrictive environment. In addition, by November 30, 2025, all schools are required to adopt and submit the updated ODEW Model Special Education Policies and Procedures to ensure compliance with both IDEA and state

These submissions are more than just deadlines, they represent the state's accountability system and ensure schools remain eligible for continued funding and support. Systemic evidence should include documentation of practices in identification, placement, evaluation, and discipline, along with data analysis, improvement plans, and records of policy adoption. Accuracy in EMIS reporting must also be maintained throughout the year,

as this data directly informs compliance determinations.

To stay on track, I recommend schools establish internal checkpoints by completing draft evidence by mid-August, finalizing submissions by September 19, and preparing boards for timely adoption of updated model policies before the November 30 deadline. Charter School Specialists will continue to provide oversight and support, including training and document review, to ensure schools remain compliant.

**Professional Development**: In addition to compliance support, Charter School Specialists will offer a professional development session in **October 2025** on updates in Special Education. This training will provide schools with the latest information on IEP compliance and service delivery.

Helpful Reminders:

- 1. Virtual Services IEPs must clearly document when services are being provided virtually when utilizing virtual intervention specialists.
- 2. Specially Designed Instruction (SDI) Academic SDI must be provided by the certified intervention specialist. General education teachers may support, but they cannot replace the IS in delivering SDI.
- 3. Transition Services/Activities When writing transition services, provide a clear description of what the school will do by using phrases such as "will assist" or "will help" to ensure accountability and clarity.

Together, with proactive planning and collaboration, we can not only meet these requirements but also continue to build equitable, inclusive, and high-quality special education programs for all students. Together, we can ensure strong compliance and high-quality special education services for all students.
